Investigators feel this may be reward money as other CADRAIN family members have also indicated the reward money went to buy farm machinery.

- On the morning of the murder Rita recalls Mary MARCOUX coming to school looking very pale.

- police also came to the school that day.

- Does not recall lunch at home on 69-01-31.

- was not questioned by police or required to testify.

- did not discuss this issue with Albert.

- has not been questioned by any other persons.

- feels Albert is afraid of David MILGARD.

The CADRAIN family did not talk about the murder very much in front of the children.
