We understand that your detachment conducted an investigation into the death of CADRAIN who was apparently killed as a result of a hunting accident. His sister, Rita GIFFORD, has made enquiries at our Outlook Det. respecting the circumstances of his death. She has had to rely on second hand information from a brother, Dennis CADRAIN, Maple Ridge, about what took place. In view of Albert CADRAIN's past, Rita is concerned that his death may not be accidental.

Last year we interviewed CADRAIN respecting his 1969 evidence against David MILGAARD as part of our reinvestigation of the trial and allegations of wrongdoing by the Saskatoon City Police. Rita is very familiar with the details of this case and might be suspicious that MILGAARD and others would have reason to kill CADRAIN. Would you be good enough to provide us with some details of this incident so that we can reassure the family?
