On Feb. 4, 1969, I attended the Gail MILLER funeral which was held at Laura, Sask., at 2:00 p.m. This funeral was attended by Corp. MORGER, MOSHEI, R.C.M.P. and myself and I/O HEIN attended and obtained a number of photographs of people that had attended. There were possibly about 250 people in attendance at this funeral, but no one was obvious who could be suspected in being involved in this murder of Gail MILLER.

Following vehicles lic. numbers were noted:

#286-788, registered owner Dennis ELLIOTT, and was accompanied Forest STUDER,

#285--472, a 1966 Ford, grey in colour, was operated by a tall youth with long blonde hair and he had transported a number of nurses to the funeral.

#93-267, was operated by a chap in a black leather coat, wearing cowboy boots, jeans, and he was observed picking up two females passengers after the service and transporting them to the cementary. This youth, it was noted, had been around the church but not attended the funeral service and was around the church after and attended at the cementary service, but not at the church service.

Truck lic. #C35908, Ford, white over blue, was noted at the cementary with young persons in the vehicle.

An older model grey Chev. car, was #92136 was noted transporting a number of youths nurses back to Saskatoon and operated by a young male.

As a result of information received from the R.C.M.P. Regina, a call was made by Sgt. OLEKSYN and myself to 217 2nd Ave. So. were Mrs. RYAN was interviewed in regards to a knife handle which her husband who is presently in Regina, had alleged was in their suite. A check was made by Mrs. RYAN in the suite for this knife without success in locating it and she alleged that the knife that had been broken by her husband would be about a 6 or 7 inch blade and that the handle for the knife had been in the child's toy box, but was not there on our checking at our time of our call. Mrs. RYAN had stated that her husband had obtained a ride to Saskatoon from Regina on Friday evening, Jan. 31, and he had been in Regina for treatment by workmans compensation board during the entire week.

M/Sgt OLEKSYN contacted a Mr. Frazer of Diamond Cab at his home, 614 5th Ave. No., were he was shown a number of photos in regards to a passenger in which he had alleged to have transported from 130 Ave. O. So. and dropped off somewhere downtown area. This taxi fare was further checked by Det/Sgt REID who will be reporting.
