	A	I didn't read the names.
4	Q	I see. You didn't read them, but there was nothing else
		in the wallet at all, apart from two pieces of paper?

	A	of No, just two pieces of paper and some/these things that
		you put pictures in.
5	Q	I see. Were there any pictures in it?
	A	Yes, a few.
6	Q	Some pictures. Now, you mentioned something about having
	•	a spot where you put your skates on in the winter time,
		is that sort of a little cabin, or something?
	A	Yes.
7	Q	There's a stove in it, I suppose?
	A	Yes.
8	Q	And when you put your skates on, you mentioned something
		about this cabin, now where was the cabin from the school?
	A	It was in the school grounds, it was by the alley.
9	Q	Where does this alley run, is it to the west of the
		school, do you know your directions? There?
	A	Well, yes.
10	Q	What direction was the cabin then from the school?
	A	Straight that way, down there, the school was over here
		and the cabin was over here.
11	Q	So the cabin would be to the west then?
	A	Yes.
12	Q	Ahd how far would the cabin be away from the school?
	A	About four or five yards.

-	A	Something close.
