- he believes hyle FROST was working for him at the time and that either FROST or John LARONDE were dispatched to retrieve the car out of the snowbank.

- Dave ANDERSON, he believes, (ANDERSON is the tow truck driver), may now be residing in Edmonton and in fact, may be a lawyer. His father, FNU, did live in Saskatoon.
