
COMMENT

Mr. DAVIS appeared to be forthright and honest, answering without hesitation. I believe he is mistaken about the search being conducted on 69 JAN 31 because police never became aware of MILGARD until 2-3 months later and would not have made the connection to the service station. Mr. DAVIS was careful to point out that his memory is somewhat vague at this point and he could be mistaken.

In any event, a copy of this addition will be placed on MACKIE'S file so that he can be questioned re: the barricades. Rationale: will or will not demonstrate thoroughness of investigation. I would recommend that 93-541, DAVIS be concluded.

Although not specifically mentioned in the statement, Davis added that he became aware of the murder during the afternoon of 69 Jan 31. Earlier in the day, he recalls, police barricaded a number of streets in the area (including his service station) for reasons unknown to him at the time. He also recalls that police searched his service station the same day but he doesn't know whether they found anything. The members did not speak to him regarding the purpose of their search.

I questioned Davis as to the behaviour of MILGROSS 'et al' while they were at the station. He felt that they were "on something" and acting very strangely. By this, they were dancing on tables, very active moving from room to room, excitable and apparently in a happy mood. The only person sullen and withdrawn was the girl.

This date, Sgt. Cunningham and I attended Saskatoon Dist. where we interviewed George ALBERT DAVIS (B:40 JAN 25) in the presence of his wife, Joan. A statement was obtained from him by Sgt. CUNNINGHAM and he was also provided copies of his statement to Saskatoon PD dated 69 JUN 12, copies of the transcripts of prelim and trial, which were read and returned to us.

In his statement to Sgt. CUNNINGHAM, Mr. DAVIS adopted all of the above statements/transcripts as being truthful and correct. In addition, he said he was treated properly by police at all times. In fact, he said he has known D/Sgt. MACKIE for years and thinks he is a decent fellow. Furthermore, DAVIS said he has not been contacted about the MILLER by anyone else.
