- Q. Gary Leslie. Now, I believe that you did work or do now work at Belmount Texaco Service at 22nd Street and Avenue W?in Saskatoon?
  - A. Right.

- 3 Q. Are you still there?
  - A. Yah.
- 4. Q. And Mr. Campbell is the lessee and so to speak your boss there, is he?
  - A. Right.
- 5 Q. And I believe you were on duty the morning of Friday, January 31st of 1969?
  - A. That's right.
- 6 Q. And that you were despatched on a call on a tow truck that morning, is that right?
  - A. Right.
- 7 Q. What time did you go out?
  - A. I don't know, between 9:00 and 9:30, somewhere around there.

  - A. Yah, there was some people come in a car and wanted to boost their battery.

- 24 Q. And ; you took the tow truck and went, did you?
  - A. Yes.
- 25 Q. How did you Did you take anyone with you?
  - A. No, I went alone.
- 26 Q. Went alone, and did you have an address or location?
  - A. Well, I was supposed to Well, they gave me the address and I was supposed to follow them or something, or they were going to follow me, but I went in through one end of the alley and they went in on the other.
- 27 Q. Was this red and white car supposed to show you the way?
  - A. Well, they were coming down in their car and I had the address, so I figured I could find it anyway.
- 28 Q. I see, so you just set off?
  - A. Mhmn.
- 29 Q. And you went in one end of the alley and the car in the other one?
  - A. Yah.
- 30 Q. And when you got in there, what did you find?
  - A. There was a \*58, a Chev or Pontiac had been stalled in the back alley.
- 31 Q. Do you remember the colour of this car?
  - A. It was kind of a grayish colour with a darker hood on it; the hood was a different colour.
- 32 Q. I see. What did you do at or about at the stalled car?
  - A. Well, I turned the tow truck around and I gave him a boost, got him going, then I told him how much it would be and he had a ten dollar bill and I didn't have change for it, so he went back to the car and he got a

dollars worth of change.

- 33 Q. Give it a boost refers to a battery, does it?
  - A. Yah.
- 34 Q. Was that what the car needed to get it going, as far as you could see?
  - A. Yah. I think he put some gas in the carburetor too.
- 35 Q. Did you have a can of gas on your truck?
  - A. No, I didn't have a can, I think they had one.
- Oh, I see, fine. But when you say you gave it a boost to get it going, was it a matter of the engine being dead or the car being stuck in the snow?
  - A. The engine was dead, it wasn't stuck.
- 37 Q. And when you got the engine running, did you see the car move at all or ...
  - A. No, he said he was going to leave it warm up for a minute.
- 38 Q. When you were at the scene where the Pontiace, the gray one, I take it that you dealt with someone who appeared to take responsibility for the car in terms of who would pay and so on?
  - A. Yes.
- 39 Q. How many people -- Was there one or more than one persons in this party?
  - A. Well, there was, as far as I could see, there wasn't anybody in the Pontiac, in the gray one, but in the other one I knew there was a girl in there, because I could see her and then the driver, but I don't know if there was any others or not.
- 40 Q. That's in the red and white car?
  - A. Yah.

- 41 Q. That came back?
  - A. Yah,
- 42 Q. And I presume that s the same one that had been at the station?
  - A. Yah.
- 43 Q. Now, did you deal with someone then who came out of the red and white car?
  - A. Well, the one that seemed to be the owner of the car, like that had come up and asked for a boost.
- Q. Correct me if I'm wrong, but I presume he got out of the red and white ear?
  - A. Yah, he come over and give me a hand when I was getting it started.
- 45 Q. Right, and do I understand how man y When he had got out, how many people could you see, or that you are sware of, or that you know were still in the Pontiac, if any?
  - A. Well, just the driver and the girl is all I really noticed.
- 46 Q. I see. And then now can you Excuse me, is the person who dealt with you and talked about paying for the Pontiac and appeared to I take it, be in charge of it, or the driver, is he in court here today? Would you have a look around please?
  - A. It's hard to really say because you boost so many you don't really pay too much attention.
- 47 Q. Alright.
  - A I couldn't really say.
- 48 Q. Pardon?
  - A. I couldn't really say.

- 49 Q. Okay, fine.
  - COURT: You say you can't identify him?
  - A. Right.
  - MR. CALDWELL: What age of a person was it?
  - A. Young. Seemed fairly young, slender build.
- 50 Q. And this was a male though?
  - A. Right.
- 51 Q. And did you retain or get or keep the license number of the Pontiac car?
  - A. Yes, I did,
- 52 Q. And what did you do with your record of it?
  - A. I left it on the , we had a little pad on the dash of the tow truck, I just left it on there.
- 53 Q. Are those things preserved or not?
  - A. Well, just for the time being, like, you know, because, you know, I wouldn't have taken it down but I never got the full bill paid so I figured I'd take it down.
- 54 Q. This is for your records at the station?
  - A. Yah.
- 55 Q. At any rate you haven't kept the note?
  - A. No.
- 56 Q. And I don't suppose you ofcourse remember the license mumber?
  - A. No, I was trying to recall, I don't know, I think maybe the frist two number were 3 0.
- 57 Q. Okay. Now, what did you do once you got that car boosted and the engine running?
  - A. Well, I asked him for how much it was like and he offered me the ten and I dish t have change for it, so he went back to the car to see if he could get some

change and he got a dollars worth of change and he said as soon as the car warmed up he would come up and pay it.

- 58 I see. And it was a ten dollar bill that you were offered from this chap, was it?
  - Yah. A.
- What did you do then? 59 Q.
  - I went back to the garage. A.
- Did you see anymore of the Pontias/or the person 60 Q. who you had been dealing with?
  - A. No, I didn't.
- 61 And you went out alone on that call? Q.
  - A. Yah.

  - A. Yes, it was awhile after.
- 8 Q. Awhile after?
  - A. Yah.
