- Was in the same alley a couple of days later and recalls the plastic tent at the scene and a police officer finding a knife.
- Was friends with Rita CADRAIN at the time.
- Rita CADRAIN told her that around the time of murder (exact date/time to be determined) someone unknown to her was sleeping in her ~~the~~ bedroom.
- Rita CADRAIN had a bedroom in the basement of the CADRAIN house.

In 1969 Linda DUFFUS resided with her parents at 1502 20th St West Saskatoon, Sask. It appears Linda DUFFUS was the first person to find the body of Lail MILLER on 69-01-31.

DUFFUS was also a friend to Rita CADRAIN, Albert CADRAIN's sister.

The taped statement of DUFFUS is attached and details her recollection of locating MILLER'S body in the alley between Ave O and Ave N on 69-1-31.

DUFFUS also related observing the S.C.P. in the alley on the following

days and specifically the presence of a plastic tent erected over the murder scene. She states she can recall a policeman at the scene finding a knife.

DUFFUS indicated that she was a friend to Rita CADRAIN, Albert's younger sister. Rita had told her that she was frightened to stay in her bedroom downstairs because she had found blood stained clothes in her room. She felt that this had occurred around the time of the murder.

DUFFUS's statement is most complete and tape recorded. The information concerning Rita CADRAIN will be pursued during her interview as well as other family members. DUFFUS was most sincere in her relating events as she remembers.

This is new information and not related to specific issues.

DUFFUS has never been interviewed by police. She did not testify @ trial.
