B) MILLER catches bus at either Ave O or N at 7:04 AM. Transfers to Route 3 bus at 2nd Ave & 23rd St. & would arrive at City Hospital 7:25 AM.

MILLER commenced work at 7:30 AM City Hospital. It is more likely she would catch the 7:04 AM bus but of course that cannot be stated categorically.

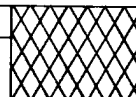

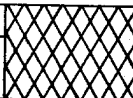
