Albert first started telling her about the MILGAARD issue about six months after they met. Albert was in a good state of mind and not taking drugs at this time according to Barbara.

Albert told her about MILGAARD coming to the house with blood on his pants & the following:

MILGAARD wanted to get out of town.

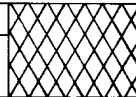

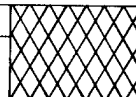
