he came ~~to~~ to my school and he picked me up at lunch, I missed the afternoon and he had stolen a car from Manitoba. He told me he stole a Pontiac '64 dark red with Manitoba plates. He used this car to drive around. We picked up two girls at the Pancake House (Smitty) and they drove around with us too. Then he asked me to go to Vancouver with him and I did and that night Monday we left Regina in that stolen car. Bonnie and "short" dark girl were the other two and Ron Wilson came with us. We stopped at Salmon Arm and David picked up some drugs that they had hidden in a brown cabin underneath a dresser. This is a cottage at a lake by Salmon Arm. He got into this cottage by breaking a window. He told me he was there before; he got picked up for drugs at Salmon Arm a while before I met him. He couldn't go back to B.C. until he was 18. We got a dime or nickel or both bag of marijuana and David + Ron and 2 hitch hikers we picked up by the gas station in the mountains. Then we went to Vancouver all seven of us. In 006501

I went to this place on 7th Ave west and before I caught the plane back to Regina I went back to the hotel room and returned the marijuana to David except for an ounce. The welfare was now looking after me. I had the marijuana on me while I was in their house. I returned to Regina and the next time I saw David was about 3 weeks later. He got picked up in ~~Regina~~^{Y.M.C.} Vancouver during these 3 weeks, they never convicted him.

In May 1968 he was in the city (Regina) for a week. He was trying to sell marijuana and he gave it to me to keep for him. I just remember that when I had come back from Vancouver my Dad found the oz of marijuana and I talked to the RCMP in Regina about it and they were trying to get enough on David to charge him with giving it to me. 006503

about made a living stealing and selling drugs and sold an underground paper. After about a month we went to hangenberg and his parents weren't home we stayed there for about a week and a half - two weeks. During this time he forced me to suck him off once. He was pretty rough to me that night they pushing me around. He said 'now you are going to be my prostitute'. The rest of the night we didn't talk to each other very much. We would go back and forth to Regina and he would go out with other girls.

We went back to Regina stayed there for a couple of weeks and we went out with John. John (the Queen) usually buys for the boys that is dresses. Another thing about David he stayed with John. Everyone talks about John being a homo sexual. David told me he likes both men and girls told me he was bisexual. I wouldn't tell whether this was the truth or not. He doesn't like to fight with other men.

During the Regina Exhibition we were staying at Ken Hynes' and Janochki's on 7th of August we broke up for good. my parents pushed me up in Regina and I went to 54. Millien Cres.

after a week he phoned me in St. Albert and I didn't talk to him because it was collect.

During the exhibition in Regina we had a fight. That night he forced me to have intercourse with him.

David wrote me that he was going to court in Vancouver for trafficking and possession. He told me he was sorry for treating me like an animal and said he was going to change.

In Jan 6 and 7th this year he stopped in Edmonton. I met him at the Sanctuary we just talked, he said he had been going into Regina from Haysburg. He was travelling by train with his mom and said he was going to straighten out.

A week after he phoned that he was on probation that he couldn't go to B.C. until he was 21 I didn't see him at this time.

The next time I saw David Mulgaard was on Saturday Feb. 1st /69 at 6³⁰ pm, he told me that he ~~arrived~~ arrived in Edmonton early Friday January 31/69 so that was Saturday morning I suspected that he broke into the Sanctuary that night (Saturday) morning. The Sanctuary had been broken into and the other guys Ron Wilson, Shortz and Mabey

told me that they weren't actually watching but when David came back to the car the door was open in the Sanctum. Ron Wilson told me David told him the door was open. ~~David told~~

He mentioned something about getting a bag of marijuana back to the girl in Regina, to me it seemed not like David to do something like this. They sold some marijuana at the Sanctum got about 15 dollars from some boys and girls one dime bag one nickel bag. This is all the marijuana he had, as far as I know. an old looking thing I looked into it the next morning, I saw some rylons in it, they were used once just thrown in. I asked him about them he said they were Nicky's. There was a writing pad, 2 pair of pants, a white shirt, some 2 or 3 pair of deer sweat. These pants were dirty and used, the shirt was clean and not worned very good. They said they wanted to go to Calgary. They talked about stealing things like bikes breaking and entering here and or in Calgary.

He left the hotel about 11⁰⁰ am the next morning (Sunday morning)

They sounded like they came straight to Edmonton from Regina no mention of Calgary and Saskatoon was made.

In Langenberg he was fooling around with a knife a big butcher knife he sort of would point it at my stomach and just say something like "I'm going to kill you" this seemed like he was just fooling around.

In Langenberg in his dresser, were pictures of two girls and I think that he said one was named Gail. They were the type you would take at the Bay or one of the stores. He said the picture of Gail was taken in Winnipeg.
