- recalls being questioned only once by police for a "lie detector".

Sharon DANIELS (nee WILLIAMS) interviewed in Edmonton this date. MS. DANIELS used to go out with David MILGARD and travel around with him. She broke up with MILGARD in September of 1968. At which she moved to Edmonton with her parents. Recalls David MILGARD, Ronald WILSON and an unknown man and woman visiting her in Norway on February of 1969. States they met at a teen centre. MS. DANIELS does not recall anything unusual. They only spent one evening together.

The only interview she recalls by police was for a lie detector test which she believes took place in a hotel. Did not recall giving a statement though. MS. DANIELS does not recall the statement she gave to Detective MALANOVICH on 69-05-20. Qovs cont.
