A. I think it was in a hotel room, I think it
was in Edmonton.

Q. When was the police officer from?

A. Saskatoon

Q. Was he with the City Police or RCMP?

A. I don't remember

Q. Why did they test you?

A. I guess because I knew David.

Q. Do you know of anyone else who was given
a lie detector test?

- Q Do you recall if David mentioned to you he had been in Saskatoon?
- A I don't recall at that time.
- Q Did David ever tell you about any criminal activity he may have been involved in during this trip to St Albert?
- A No, nothing.
- Q Did David ever confess to you, a confidante, in your that he had committed a serious crime in Saskatoon?
- A No
- Q Did anyone else in the group with David mention anything about David possibly being involved in an attack on a girl in Saskatoon?
- A Not that I can recall
- Q Were you aware of David's activities or the month prior to Jan 1965?
- A Not that I can recall
- Q Do you ever recall being physically assaulted by David?
- A No
- Q Did David ever punch you over stupid things?
- A I can't recall.
- Q Do you remember what David was wearing when you first saw him on his visit to St Albert?
- A - No
- Q Did David or any of the people he was with have any luggage?
- A I think that I can recall.

Q - Do you recall David playing with a gun and playing what is known as Russian Roulette?

A - It seems to me there was an incident similar to that?

Q - Tell me about it.

A - I can't really remember any of it, oh gosh.

Q - Do you recall David having a gun?

A - I remember the incident but don't remember the gun, but don't remember what it looked like.

Q - Tell me about the incident?

A - I think he was playing games with me

Q - Did he point the gun at you?

A - Yes

Q - Then what?

A - I don't remember

Q - Was the gun loaded?

A - I don't know

Q - Can you describe David's character and personality as you remember it?

A - Well he was always wanting or looking to be the top dog. He always had to know what was going on.

Q - Did his personality change for no reason or was he pretty much the same all the time?

A - I think he was pretty much the same all the time.

Q - Did David use drugs in those days?

A - ~~No~~ Yes

Q - ~~Can~~ Can you elaborate?

A - Oh, I used LSD, speed, Marijuana, I can't recall any others

Q - How did his personality change, if it did, while using drugs?

A - He seemed to get sorta' and would do silly things, ma

dangerous things, but I can't recall any incidents.

Q - Did he do things that concerned you?

A - I can't recall.

Q - Are you afraid of David MILLETTARD?

A - I don't think so.

Q - Do you recall if David ever carried a knife?

A - I can't recall.

Q - Do you remember any vehicles David used in 1968 and early 1969?

A - No

Q - Were you ever at David's home in Haensenburg, St. Paul?

A - Yes

Q - Who was present?

A - His mother and sister and that's it.

Q - Do you recall ever seeing introduced to any of David's girlfriends at the time?

A - No

Q - Do you remember seeing any photos of girls that David knew, while you were at the MILLETTARD home in Haensenburg?

A - No.

Q - Were you ever threatened or sexually assaulted by David MILLETTARD?

A - Not that I can remember, no.

Q - While at the MILLETTARD home in Haensenburg, do you recall an incident when David had a butcher knife and may have said something like "I'm going to kill you".

A - I can't recall that.

Q - Do you know Shelly CIPRAN?

A - I don't know much about Shelly, doesn't remember her, but I can't recall

A Do you know the name Michael JOHN?

A Just from seeing it in the newspaper, I don't know her

A Do you know Ronald WILSON?

A Yes

A Where from?

A Legena

A How?

A I guess I met him in the same group. I may have met him before I met David, maybe not. I really don't know.

A Do you know Debbie HALL?

A No

A Do you know Udo FRANZ?

A Yes

A Explain?

A I met her in Legena, after I met David. Once I moved back to Alberta we kept in contact. About 1975-1976 I lost contact with her.

A Do you recall any conversation you and Udo may have had about MURKARD and his murder conviction?

A She never said anything in her letter. I don't remember her saying anything about it.

A When was the last time you saw Udo?

A In 1974, her and her husband visited us in Calgary.

A Do the names LIPCHUK and MARENKO ring a bell?

A I think his name is George LIPCHUK, he was part of the group.

A How about MELVILLE?

A I can't remember him, but I remember the name.

Q Sharon, I wish to show you the statement you gave the police in 1965 concerning your activities and association with David MULCAHY. Please read it carefully and tell me what portion of it refresh your memory.

A - Ok

Q - Sharon, you have now read over your 1965 statement, do you have any comments?

A - No, I guess not, I can't remember any of it

Q - Did it refresh your memory?

A - I can't remember staying in a motel overnight when they came to St Albert

Q - Sharon, one part of your statement states "The next time I saw David MULCAHY was on Saturday Feb 11th at 6:30 pm, he told me that he arrived in Edmonton early Friday January 31/65, so that was Saturday morning. I suspected that he broke into the Sanctum that night (Saturday) morning. Do you recall David telling you he arrived in Edmonton on Friday or Saturday?"

A - I can't recall

Q - Did you believe David contacted you shortly after arriving in Edmonton, or was he doing other things before getting in touch with? 053927

A - I just don't remember

Q - Do you now recall anything of the clothes David was wearing?

A - I can't even remember what I had said in the statement

Q - Do you recall a suitcase being carried by someone in David's car, either at your place, but in particular,

the motel room?

A No, I can't ever recall the hotel room.

Q In the statement it is mentioned David had a brown jacket shedded down the front & he said acid in it. Do you recall the jacket?

A No I don't.

Q Do you recall anything made the butcher knife incident in Hansaburg, when David said something like "I'm going to kill you".

A No.

Q Did you see any blood on David's clothing while he was at your place in St Albert or while the group of you were at the motel?

A No.

Q When did you first hear that David was a suspect in a murder?

A I think it was from the police in March when they came. I don't think I heard about it before that.

Q Did David ever call you or write you letter after he was visiting you in St Albert?

A I can't recall.

Q How many visits did you have from the police over this?

A I can only remember the one and nothing after that, that I can remember.

Q In 1968 and 1969 were you an active drug user?

A whenever the crowd I was with got any I would.

~~Q~~^{RP} I was an occasional user of speed & LSD.

Q Sharon, do you possess any information or evidence that would assist in proving that David MILCAKOVIC did not commit the murder of Carl MILLER
