I have never received any prank phone calls. Bail Miller had mentioned about 2 to 3 weeks before she was murdered that she had received some calls, I don't think it was from the same guy. It may have been friends of her, Betty would know more about this. Bail had also on occasion had other girls answer her phone for her the way have been because of her Spence and the trouble she was having with him.

On the morning of Jan 31/69 when I last saw Bail, I saw her walking standing in the 2nd floor hallway and I was going up the stairs to my room. I saw her in her white uniform, hair combed. I did not see her face or just the profile as she walked <sup>right</sup> <sup>there</sup> by. I doubt if she saw me at this time.

I did not go back to bed but rather got ready to go to class, Adeline Nyozai

I heard no one or saw no one else in the house other than Gail, possibly Betty who waits at the front door for her ride also Hugo, I don't remember if I went into Hugo's room that morning, but Nick & Jack & Hugo's roommates were gone at this time

I did not hear anything while in my room with the window open, nor did I see anything in the lane when we drove away. Vision was poor due to the fog that morning.
