At 1:30 p.m. a telephone call was received from Arthur Rose cleaners 5th Ave. & 25th St. managed by Marg McDONALD, of 306 Greg Ave. We called there at 1:40 p.m. and interviewed Marg McDONALD and she stated that after 1:30 p.m., this date, one W. YUZDEPSKI of 50 Or 5A Airling trailer Court had brought in a siwash sweater with blood on both sleeves. Fairly soaked in and around the cuff area, splatters of blood on the sleeves and front of sweater.

At 1:45 p.m., the siwash was seized from Arthur Rose at which time it was initialed, dated, time also marked and it was also done by Marg McDONALD.

On checking the city directory it was found that W. YUZDEPSKI lived in the 2500 blk. Elyl. Dr. N., and stated that he worked for B.B. TORCHINSKY on 105th St. At 2:40 p.m., a call was made to B.B. TORCHINSKY and at this time one Wilfred YUZDEPSKI of 65 Aipline Trailer Court was interviewed. He stated that he owned the siwash sweater which was taken into Arthur Roses 5th Ave. & 25th St. after 1:30 p.m. this date, and he had received the blood on the siwash sweater when he was at 1213 - 23rd St. W., the home of his mother at which time in company with his brother Elmer KOWALENKO 1405 Early Ave., there had been a scuffle between KOWALENKO and Don SEMCHYSHEN who was staying at his mothers place 1213 - 23rd St. W. when they attempted to evict him and his common-law wife and Harvey. This happened between 10:00 and 10:30 p.m. on Jan 30/69.

A call was made at 1405 Early Dr. where Mrs. KOWALENKO was interviewed and stated that her husband came home with bashed nuckles and skinned, stated he had had trouble at 1213 - 23rd St. W. She is the brother of Wilfred YUZDEPSKI.

This evening a call was made at 1213 - 23rd St. W., Mrs. YUZDEPSKY was interviewed re: her son Wilfred with blood on his swash and stated that Elmer her son-in-law had had a fight with Don SEMCHYSHEN on the night of Jan 30/69, and SEMCHYSHEN had received a bloody nose and Wilfred, in trying to break up the fight, had got blood over his swash sweater at which time she had attempted to remove the blood and had the dirty clothes covered with blood in her home at the present time. Mrs. YUZDEPSKY stated that Don SEMCHYSHEN and Ann HARVEY, his common-law wife had gone over to Mike KARACHEKS at 306 Ave. N. N.

A call was made at 306 Ave. N. N., and Ann HARVEY, the common-law wife of Don SEMCHYSHEN, was interviewed and stated that Don received black eye and nose bleed and bruises to his face at 1213 - 23rd St. W. at which time they had come over to 306 Ave. N. N. and had been there all night. This was

During the afternoon information was received from one Fred BUNIA, 309 5th Ave. N., Mgr. beverage room at Bessborough Hotel, who stated that a former part time waiter, namely one Ed FISCHER, Saskatoon photo #11004, had the previous Sat. assaulted and raped a girl at a house party who was a friend of one of the girls working at the Bessborough by the name of Marie.

A call was made at the Bessborough Hotel tonight and spoke to Marie, who stated that she was living with one Willy, she would not give last names, who was her girlfriend, and this girlfriend had been taken to the party by Marie, at which place Ed FISCHER had been at this party and after Marie had gone home Willy had been forcefully raped by Ed. FISCHER and another one or two male persons at the house. She did not report this to the Police. Marie was asked if she would talk to Willy and see if she would talk to the Police re this alleged rape and to see if it would be able to help us in connection with investigation on this report. She stated that she would have to talk to Willy and would call us on Feb. 1/69 after 7:00 p.m.
